

**FREDA T. ROOF MEMORIAL**  
**SCHOLARSHIP APPLICATION**

**GENERAL INFORMATION**

1. Ms. Roof established this scholarship Fund in order to benefit worthy, deserving, and needy students who are obtaining a college or university education in the state of Colorado. In October of 1997, the Denver Probate Court reformed the will of Freda Roof, permitting the amount distributed each year be divided equally among all accredited colleges and universities in Colorado that are exempt from federal income taxation.
2. It is Ms. Roof's desire to provide assistance to these worthy, deserving, and needy students in order to defray expenses of tuition, fees, living and transportation costs, and other expenses necessary to the education of the individuals selected by the colleges and universities. In determining the amounts to be given to any individual, each college and university shall give consideration to the needs, circumstances, and abilities of the specific individual, the apparent intention and ability of the individual to repay the amount received, and such other factors as may appear to be pertinent. The sums advanced to any individual are considered a gift, but it is Ms. Roof's sincere hope that the individuals selected as recipients of assistance will be of such character that they will feel a strong moral obligation to repay the amount received in order that the benefits may be continued over a substantial period of time.
3. The recipient will be chosen by the Otero Junior College Scholarship Committee on the basis outlined above, letters of recommendation as well as the needs, circumstances, and the abilities of the candidate. This will also be used to determine the amount of the scholarship.
4. Scholarships will be awarded for the 2012-2013.
